



TOWNSHIP OF GUELPH/ERAMOSIA NOTICE VACANCIES ON COMMITTEES

TAKE NOTICE that the Township of Guelph/Eramosa is inviting applications from persons who wish to represent the Township in the following positions for the upcoming four year term of Council, from November 15 2022 to November 14, 2026:

POUNDKEEPER (1 position available)

In accordance with the Pounds Act, the Poundkeeper shall investigate and cause to be impounded any large animal and farm livestock, other than dogs, found being at large or trespassing on public or private property or public road allowance and cause them to be sold, if they are not claimed within a reasonable time. **Payment for this position is \$90.00 per call, plus mileage.**

LIVESTOCK VALUER (1 position available)

The Livestock, Poultry and Honey Bee Protection Act requires the Council of every local municipality to appoint one or more Livestock Valuers. The Municipality is responsible for claims wherein the livestock or poultry has been killed or injured by a dog or a wolf. The Livestock Valuer investigates the claims and determines the amount to be paid to the owner of the injured or killed livestock. **Payment for this position is \$90.00 per call, plus mileage.**

PROPERTY STANDARDS/FENCE VIEWERS (3 positions available)

The Township of Guelph/Eramosa has set standards for the maintenance and occupancy of properties within its boundaries. The function of this committee is twofold: 1) to hear appeals, filed by owners or occupants of property within the Township of Guelph/Eramosa, after they have been served with an order to maintain their property according to the standards prescribed by Property Standards By-law 50/2018, this may be done in-person or virtually (at Committee's discretion); as well as 2) arbitrate when the owners of a property are unable to reach an agreement when a new line fence is to be constructed or an existing line fence is to be reconstructed or repaired (concordant to the *Line Fences Act*).

The Property Standards/Fence Viewers Committee will meet when required and will not have a set meeting schedule. **Payment for this position is \$120.00 per meeting, plus mileage.**

COMMITTEE OF ADJUSTMENT (3 appointments)

The Committee of Adjustment is a quasi-judicial body and its main function is to consider Minor Variance applications to the Township's Zoning By-law, in accordance with the provisions of the *Planning Act*. The Committee may meet up to twice a month in the evening, dependent upon applications submitted to the Committee. **Payment for this position is \$75.00 per meeting.**

HERITAGE COMMITTEE (at least 3 Members of the Public)

The purpose of the Heritage Committee is to support civic interest in heritage preservation and assist Council on matters relating to historical and architectural conservation. The Committee will meet on a quarterly basis (every 3 months), in-person, at a date and time to be determined by the Committee. **This is an unpaid appointment.**

GUELPH CEMETARY COMMISSION (currently two positions)

The Commission is responsible for maintaining and managing and the Cemetery (Woodlawn Memorial Park). The Guelph Cemetery Commission meets on the third Tuesday of every month except July or August. The Guelph Cemetery Commission meetings begin at 4:15 pm at the offices of Woodlawn Memorial Park, for approximately 2 hours. **This is an unpaid appointment.**
